Composition: Wheat feed flour, soybean meal, rapeseed meal, hulled sunflower seed flour, sugar beet molasses, urea and its derivatives, calcium carbonate, monocalcium phosphate, sodium chloride, magnesium oxide.

Method of administration: BOVI BB supplementary feed for fattening cattle over 250 kg. It must be mixed with the daily feed ration at a maximum of 10% (10 kg/100 kg of feed). The maximum daily consumption of Bovi BB is 1.30 kg per animal per day, depending on the animal's body weight. Due to its urea content, the Bovi BB supplementary feed mixture can also be consumed by animals with advanced rumen function in the presence of easily digestible carbohydrates.

The Bovi BB supplementary feed mixture may only be mixed with other feeds, in the ratio specified on the declaration.

Recipe

suggestion: 250-350 kg: Maize 60%, Cereals 20%, Wheat feed flour 10%, BOVI BB 10%. +2-5 kg/ton Minazel.

350-550 kg: Maize 60%, Cereals 22%, Wheat feed flour 10%, BOVI BB 8%. +2-5 kg/ton Minazel.
